#### Detail of Objectives proposing to amend

- a. The Company's objectives were, formerly 41 items, added with 3 items, constituting 44 items of objectives as follows:
  - Item (42) To be engaged to sell, buy and sell all kinds of products via electronic methods.
  - **Item (43)** To manufacture and distribute systems and equipment for measuring and controlling the air conditioning system or air conditioner, air quality display and control systems and equipment for air conditioning system, air conditioner and other machinery, as well as systems and equipment for administration of energy and internal environment of the building.

## b. Items (13), (22), (23), (39), and (41) of the Company's objectives were amended as follows:

## Item (13

- <u>Former</u> (13) To trade machine, engine, machine tool, labor-saving device, vehicle, electric generator, water pump, sewage treatment machine and garbage disposing machine.
- <u>Amendment</u> (13) To trade <u>and maintain</u> machine<u>ry</u>, <u>wheeled machinery</u>, engine, <u>wheeled labor-</u> <u>engine</u>, machine tool, <u>wheeled machine tool</u>, labor-saving device, <u>wheeled labor-</u> <u>saving device</u>, <u>all kinds of land</u>, <u>water and air</u> vehicle, electric generator, water pump, sewage treatment machine, garbage disposing machine, <u>including equipment</u> <u>and spare parts thereof, both domestically and internationally.</u>

# Item (22)

- <u>Former</u> (22) To bid for sale of goods as per the objectives to person, group of persons, juristic person, government sector and state organization both domestically and internationally.
- <u>Amendment</u> (22) <u>To buy and sell</u> articles and goods as per the <u>objectives acquired by ordinary</u> <u>and electronic biddings</u> for person, group of persons, juristic person, government sector, <u>skytrain business</u>, <u>business of State Railway of Thailand</u>, <u>business of</u> electricity authority, <u>state enterprise</u>, <u>public organization</u> and state organization both domestically and internationally.

Item (23)

- <u>Former</u> (23) To contract for construction of building, commercial building, residential building, office, road, bridge, dam, tunnel, as well as all types of other constructions and civil works.
- <u>Amendment</u> (23) To contract for construction <u>and repair</u> of building, commercial building, residential building, office, road, bridge, dam, tunnel, <u>factory and power plant of</u> <u>all kinds, including electrical generating and distributing systems, electric</u> <u>generator, electricity station; to contract for installation of electrical system as</u> <u>per the objectives, conveyor belt system, coal and harbor conveyor belt</u>, as well as all types of other constructions and civil works.
