## 4.2 Through the scripless System.

The brokers will inform Thailand Securities Depository Company Limited (TSD) in order to withdraw a warrant certificate or a replacement prescribed by the SET used as evidences to purchase the ordinary shares, and then proceed with the procedure in clause 4.

8. Other conditions

In case that the warrant holder submits incomplete evidence either the warrant certificate or substitution of warrant certificate, or the Company does not duly receive full amount of the payment specified in the subscription form, or the Company finds that the information filled in the subscription form is incomplete and/ or inaccurate, or the tax stamp is not fully affixed to the document in accordance with the laws and regulations, the warrant holder must correct and/ or fulfilled the documentation to be complied with the exercise terms and conditions within the exercise date; otherwise, the notification shall become invalidate.
